(Tech II), respectively. 911,833 shares of Common Stock are held by QP, 745,108 shares of Common Stock and 350,000 Wts are held by Cayman, 1,576,888 shares of Common Stock and 750,000 Wts are held by PE, 219,400 shares of Common Stock and 105,000 Wts are held by Tech and 1,353,600 shares of Common Stock and 645,000 Wts are held by Tech II.
