(1) The reporting person was granted 34,627 shares of common stock in connection with the settlement of performance-based restricted stock units upon the company's achievement of certain performance criteria for the 2012/2013 period. 50% of the shares vested on the date of grant and the remainder will vest on 3/1/15.

(2) Represents shares reacquired to satisfy tax withholding obligations in connection with the vesting of (a) 6,250 shares of restricted stock granted to the Reporting Person on 3/1/10 (b) 5,357 shares of restricted stock granted to the Reporting Person on 3/1/11 (c) 18,644 shares of restricted stock granted to the Reporting Person on 3/1/13 as a result of the company's achievement of certain performance criteria for 2011/2012 (the award was originally allocated to the reporting person as performance-based restricted stock units) and (d) 17,314 shares of restricted stock granted to the Reporting Person on 3/1/14 (see footnote 1).

(3) Each restricted stock unit represents a contingent right to receive one share of eBay's common stock.

(4) The reporting person received 25,000 restricted stock units subject to a four-year vesting schedule, vesting 25% on 3/1/11 and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

(5) Not Applicable.

(6) The reporting person received 21,430 restricted stock units subject to a four-year vesting schedule, vesting 25% on 3/1/12 and 25% each year thereafter. Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

(7) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/10 and 1/48th per month thereafter.

(8) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 9/1/11 and 1/48th per month thereafter.

(9) The option grant is subject to a four-year vesting schedule, vesting 12.5% on 10/1/12 and 1/48th per month thereafter.

Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.

Upon vesting, the reporting person will receive a number of shares of common stock equal to the number of restricted stock units that have vested.
