- (1) Mr. Hampton owns 50% of GeoTrends-Hampton International LLC. On August 8, 2005, GeoTrends-Hampton International LLC transferred 450,000 common shares into the personal name of George L. Hampton III.
  - (2) Mr. Hampton received these shares as the third tranche issuance of shares under a Lease Purchase and Sale Agreement dated May 11, 2004, as amended June 11, 2004 among the Issuer, Methane Energy Corp. and GeoTrends-Hampton International LLC.
  - (3) The options vest as to 25% on the date of grant and 25% every six months so that all options are vested by December 31, 2005.
  - (4) The options vest as to 25% on the date of grant and 25% every six months so that all options are vested by September 17, 2006.
