This Schedule 13D is being filed on behalf of Claudio Sgarbi relating to the shares of common stock of Freshwater Technologies, Inc., a corporation existing under the laws of the State of Nevada (the "Issuer").

#### Item 1. Security and Issuer

This Statement relates to shares of common stock with \$0.001 par value of the Issuer. The principal executive offices of the Issuer are located at 30 Denver Crescent, Suite 200, Toronto, Ontario Canada M2J 1G8.

#### Item 2. Identity and Background

- (a) Name: Claudio Sgarbi.
- (b) Residence or business address: c/o Constantakis, Cupas & Asociados CL 51 Campo Alegre, Panama City, Panama.
- (c) During the last five years, Mr. Sgarbi has not been convicted in a criminal proceeding (excluding traffic violations or similar misdemeanours).
- (d) During the last five years, Mr. Sgarbi was not a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.
- (e) Mr. Sgarbi is a citizen of Italy.

#### Item 3. Source and Amount of Funds or Other Considerations

Pursuant to a joint venture agreement between the Issuer and ELCE International Corp. ("ELCE"), the Issuer agreed to issue Claudio Sgarbi a total of 30,000,000 shares of common stock of the Issuer in consideration for Mr. Sgarbi distributing certain water activation products owned by ELCE.

The Issuer issued 10,000,000 shares of common stock on January 25, 2009, 5,000,000 shares on August 22, 2009 and 15,000,000 shares on January 25, 2010.

#### Item 4. Purpose of Transaction

Mr. Sgarbi acquired the 30,000,000 shares of common stock of the Issuer for investment purposes, but may transfer or sell such shares as necessary and in accordance with applicable securities laws.

Mr. Sgarbi does not presently have any plan or proposal which relate to or would result in the acquisition or disposition by any person of additional securities of the Issuer; an extraordinary corporate transaction involving the Issuer or its subsidiaries; a sale or transfer of a material amount of the Issuer's or its subsidiaries' assets; any material change in the present capitalization or dividend policy of the Issuer; any other material change in the Issuer's corporate structure; any changes to the Issuer's charter, bylaws or instruments corresponding thereto which may impede the acquisition of control by any person; causing a class of securities of the Issuer to be delisted from a national securities exchange or cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities

association; or a class

of equity securities of the Issuer becoming eligible for termination of registration pursuant to section 12(g)(4) of the Securities Exchange Act of 1934.

Item 5. Interest in Securities of the Issuer

The aggregate number and percentage of common stock of the Issuer beneficially owned by Mr. Sgarbi is 30,000,000 shares, or 16.6% of the Issuer, based on 180,120,000 shares of common stock outstanding as of the date of this report.

Mr. Sgarbi has the sole power to vote or direct the vote, and to dispose or direct the disposition, of 30,000,000 shares of common stock of the Issuer.

Other than as described in Item 3 above, Mr. Sgarbi has not effected any transaction in the shares of common stock of the Issuer in the past sixty days.

No person, other than Mr. Sgarbi, is known to have the right to receive or the power to direct the receipt of dividends from, or the proceeds from the sale of, the 30,000,000 shares of common stock of the Issuer.

Item 6. Contracts, Arrangements, Understandings or Relationships with Respect to Securities of the Issuer

There are no contracts, arrangements, understandings, or relationships between Mr. Sgarbi and any other person with respect to any securities of the Issuer other than as disclosed in this Schedule 13D.
