Item 1. Security and Issuer

This Schedule 13D/A (the “Statement”) is being filed on behalf of Richard A. Wright (“Wright”) and Lifewater Industries, LLC (“Lifewater”) and, together with Wright, collectively, the “Reporting Persons”) relating to the shares of common stock (the “Shares”) with \$0.001 par value per share of The Alkaline Water Company Inc. (the “Issuer”). The principal executive offices of the Issuer are located at 7730 E. Greenway Road, Suite 203, Scottsdale, AZ 85260.

Item 2. Identity and Background

This Statement is filed by the Reporting Persons.

Wright, the President, Vice-President, Chief Executive Officer, Chief Operating Officer and director of the Issuer and a citizen of the United States, has an address at 7730 E. Greenway Road, Suite 203, Scottsdale AZ 85260.

Lifewater, a limited liability company organized under the laws of the State of Arizona and engaged in the investment and development of water related technology, has an address at 7730 E. Greenway Road, Suite 203, Scottsdale AZ 85260. Wright is the manager of Lifewater.

None of Wright and the managers of Lifewater has, during the last five years, been a party to a civil proceeding of a judicial or administrative body of competent jurisdiction and as a result of such proceeding was or is subject to a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation with respect to such laws.

Pursuant to Rule 13d-3 under the Act, by reason of his relationship with Lifewater, Wright may be deemed the beneficial owner of all of the Shares beneficially owned by Lifewater. Wright and Lifewater may be regarded as a group for purposes of Rule 13d-5 under the Act.

Item 3. Source and Amount of Funds or Other Considerations

Effective August 17, 2017, the following stock options held by Wright were cancelled by the Issuer without consideration in connection with the grant of the Series D Preferred Stock to Wright:

- 60,000 stock options exercisable at a price of \$7.50 per share until October 9, 2023
- 12,000 stock options exercisable at a price of \$8.25 per share until May 12, 2019
- 60,000 stock options exercisable at a price of \$7.275 per share until May 21, 2024
- 16,000 stock options exercisable at a price of \$5.75 per share until February 18, 2020

Effective August 25, 2017, Wright became the manager of Lifewater. Accordingly, Wright acquired voting and dispositive control over 169,572 Shares owned by Lifewater.

Item 4. Purpose of Transaction

Wright acquired voting and dispositive control over 169,572 Shares owned by Lifewater upon becoming the manager of Lifewater. Wright’s stock options were cancelled in connection with the grant of the Series D Preferred Stock to Wright.

As of the date hereof, except as described in this Statement, the Reporting Persons do not have any plans or proposals which relate to or would result in:

- The acquisition by any person of additional securities of the Issuer, or the disposition of securities of the Issuer;
- An extraordinary corporate transaction, such as a merger, reorganization or liquidation, involving the Issuer or any of its subsidiaries;
- A sale or transfer of a material amount of assets of the Issuer or any of its subsidiaries;
- Any change in the present board of directors or management of the Issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- Any material change in the present capitalization or dividend policy of the Issuer;
- Any other material change in the Issuer's business or corporate structure, including but not limited to, if the Issuer is a registered closed-end investment company, any plans or proposals to make any changes in its investment policy for which a vote is required by Section 13 of the Investment Company Act of 1940;
- Changes in the Issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the issuer by any person;
- Causing a class of securities of the Issuer to be delisted from a national securities exchange or to cease to be authorized to be quoted in an inter-dealer quotation system of a registered national securities association;
- A class of equity securities of the Issuer becoming eligible for termination of registration pursuant to Section 12(g)(4) of the Act; or
- Any action similar to any of those enumerated above.

Item 5. Interest in Securities of the Issuer

As of the date hereof, the Reporting Persons beneficially own the aggregate number and percentage of outstanding Shares set forth below:
