Such shares of the Issuer's Common Stock were directly beneficially owned by the Accounts. The Conestoga Small Cap Fund beneficially owned more than 5.0% of the Issuer's issued and outstanding Common Stock.

As of December 31, 2018, the Reporting Persons indirectly beneficially owned 14.12% and 8.61% of the Issuer's issued and outstanding Common Stock (based on 3,852,835 shares of the Issuer's Common Stock outstanding as of October 26,2018 as reported by the Issuer in its Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on October 31, 2018).
