**Explanatory Note**

This Amendment No. 1 on Form 8-K/A (this Amendment) amends the Current Report on Form 8-K (the Original 8-K) of Sinclair Broadcast Group, Inc. The Original 8-K reported the Company's completion of its acquisition of certain broadcast assets from Newport Television LLC. (Newport).
