- (1) On February 17, 2010 the Issuer granted the Reporting Person a Restricted Stock Award (RSA) of 11,657 restricted shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan) which were scheduled to vest in two equal annual installments on the second and third anniversary of the date of grant. On February 17, 2013, the remaining 5,828 shares of the originally granted RSAs vested, of which 2,163 shares were surrendered by the Reporting Person in order to satisfy tax withholding obligations. This form is being filed to reflect the surrender of such shares to satisfy the Reporting Person's tax withholding obligation.
- (2) Between May 23, 2012 and February 19, 2013 the Reporting Person acquired 17 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc. Dividend Reinvestment Plan. The information in this report is based on a statement dated

- (3) 20,262 of these shares are restricted stock units.

(4) Between May 23, 2012 and February 19, 2013 the Reporting Person acquired 120 shares of First Midwest Bancorp, Inc. Common Stock pursuant to the Dividend Reinvestment feature under the First Midwest Bancorp, Inc. Non-Qualified Gain Deferral Plan. The information in this report is based on a plan statement dated January 15, 2013.

(5) Between May 23, 2012 and February 19, 2013 the Reporting Person acquired 63 shares of First Midwest Bancorp, Inc. Common Stock under the First Midwest Bancorp, Inc.
