However, the Company subsequently determined that stock options to purchase 50,000 shares of common stock were not validly granted pursuant to
- (1) the Company's Equity Incentive Plan because in aggregate with other equity awards in 2012 they exceeded the limit on the number of stock options that may be granted to any individual participant within one calendar year. Accordingly, the attempted grant of these excess stock options was ineffective, and they were never granted to the reporting person. The reporting person is filing this amendment to report that no stock options were acquired on December 21, 2012.
