- (1) Reflects a 2015 BlackRock Performance Incentive Plan award value of \$1,799,737 (converted to 5,234 Restricted Stock Units by dividing the award value by \$343.855, which was the average of the high and low price per share of Common Stock on January 16, 2015). The award was disclosed in the table on page 35 of BlackRock's 2015 Proxy Statement in the column headed "Long-Term Incentive Award (BPIP)". As outlined in BlackRock's 2015 Proxy Statement, the award was subject to adjustment based on certain performance metrics approved by the Management Development and Compensation Committee at the time of the award. Based on the Company's performance, the Restricted Stock Units vesting represent 109.5% of original award.
- (2) Includes Common Stock and Restricted Stock Units that will vest over a period of 1 to 3 years. Each Restricted Stock Unit is payable solely by delivery of an equal number of shares of Common Stock.
