## Explanation of Responses:

- (1) On January 2, 2007, the Issuer entered into an agreement with Willing L. Biddle (the "Reporting Person") whereby the Reporting Person was granted a restricted stock award of 5,000 shares of Class A Common Stock pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan (the "Restricted Stock Award Plan").
- (2) This figure includes 102,500 shares of Class A Common Stock issued pursuant to the Restricted Stock Award Plan. On January 2, 2007, restrictions applicable to a previously reported grant of 5,000 restricted shares of Class A Common Stock lapsed resulting in the Reporting Person becoming fully vested in such shares. This resulted in no change in the number of shares beneficially owned by the Reporting Person.
- (3) Mr. Biddle is the direct beneficial owner of 159,200 shares of Class A Common Stock (including the 102,500 restricted shares referenced in footnote (2)). He is the indirect beneficial owner of 4,475 additional shares of Class A Common Stock which are owned beneficially and of record by Catherine U. Biddle, the Reporting Person's wife, and 555 additional shares of Class A Common Stock which are owned by the Catherine U. Biddle IRA for the benefit of Catherine U. Biddle.
