- (1) Mr. Urstadt is the Chairman and a controlling shareholder of Urstadt Property Company, Inc., a Delaware corporation ("UPCO"). On August 14, 2012, Urstadt Realty Shares II L.P., a Delaware limited partnership of which UPCO is the general partner and Mr. Urstadt is the limited partner ("URS II"), made a distribution of 661,193 shares of Common Stock of the Issuer to Mr. Urstadt. This distribution had no effect on Mr. Urstadt's beneficial ownership of Common Stock of the Issuer.
- (2) This figure includes 531,250 restricted shares of Common Stock issued pursuant to the Issuer's Amended and Restated Restricted Stock Award Plan, all of which are held by URS II.
- (3) Mr. Urstadt is the direct beneficial owner of 674,743 shares of Common Stock of the Issuer. He is the indirect beneficial owner of 3,407,968 shares of Common Stock, of which 536,466 shares are held by URS II (including the 531,250 restricted shares referenced in Footnote 2), 883,690 shares are held by UPCO, 41,050 shares are held by Elinor Urstadt, Mr. Urstadt's wife, 4,331 shares are held by the Urstadt Biddle Properties Inc. Excess Benefit and Deferred Compensation Plan of 2005 for the benefit of Mr. Urstadt and 1,942,431 shares are held by Urstadt Realty Associates Co LP, a Delaware limited partnership, of which UPCO is the general partner and Mr. Urstadt, Mrs. Urstadt, the Catherine U. Biddle Irrevocable Trust and the Charles D. Urstadt Irrevocable Trust (for each of which trusts
