(collectively, the "Investors"), claiming that the Company was purportedly in default of certain obligations under the Company's notes issued to the Investors due to refusal by the Company to honor any further conversion of notes to common stock. The Company expected to receive the Notice of Default, and is engaged in negotiations with the Investors to resolve the matter. As such, the Company contemplates that either the Investors or the Company will initiate litigation if these negotiations do not produce a resolution.
