(1) Consists of 38,500 shares of nonqualified stock options ("Options") granted to Mr. Cinnamon on January 17, 2008. Each Option will have a one year term, and will be subject to vesting based on the Mr. Cinnamon's continuing service with the Company, with the shares vesting on the anniversary of the grant date. Each Option will otherwise be subject to the terms and conditions of a standard form of stock option agreement as approved by the Compensation Committee of the Company.

(2) Includes 313,000 shares of nonqualified stock options granted on September 7, 2007 which vest 30% annually on each of the first three anniversaries of the grant date.
