The principal cause of our failure to timely file our Quarterly Report on Form 10-QSB for the period ended February 28, 2006, is that the person responsible for preparing the report and related financial statements has also been responsible for negotiating several letters of intent that are outstanding to acquire operating businesses that could be acquired by the Company and locating the capital to close the transaction(s). The Company's auditors have also had delays attributable to the seasonal workload due to the April 15th tax filing deadline. As a result, additional time is required to prepare the unaudited financial statements for the Company's auditors to review and to complete the preparation of the Quarterly Report on Form 10-QSB in time for the April 15, 2006 deadline without unreasonable effort or expense.
