Following the completion of this transaction, the reporting person is the beneficial owner of a total of 2,701,036 shares of common stock of iStar Financial Inc., of which 2,003,692 shares are owned directly and 697,344 shares are owned indirectly through three family trusts. In addition, the reporting person owns 41,073 restricted stock units, representing the right to receive an equivalent number of shares of iStar common stock if and when the units have vested.
