- (1) The 332 shares of phantom stock represent the deferral of one quarter of the reporting person's annual payment for Board service for the 2007-2008 Board year and are deferred under CONSOL Energy Inc.'s (the "Company's") 1999 Director Deferred Compensation Plan, as amended (the "Deferred Compensation Plan"). Each share of phantom stock is the economic equivalent of one share of common stock, \$0.01 par value per share, of the Company. The shares of phantom stock are payable in cash and generally only after the reporting person is no longer a member of the Company's board of directors. These shares of phantom stock are in addition to the 30,662 shares of phantom stock, including dividend equivalent rights, previously held by the reporting person in the Deferred Compensation Plan.
