The reporting person has elected to defer payment of director stock compensation pursuant to the HCC Insurance Holdings, Inc. (1) Nonqualified Deferred Compensation Plan for Non-Employee Directors (the "Plan"), which is payable in shares of common stock of HCC Insurance Holdings, Inc. ("HCC Common Stock"). This number represents her deferral of such stock.

At the time of payout, the Deferred Stock deemed to be held in the bookkeeping account balance will be paid to the reporting person as (2) shares of HCC Common Stock.
