- (1) On February 17, 2006, Mr. Wallace received a grant of restricted stock units ("RSUs") covering 75,000 shares of KLA-Tencor common stock. On February 17, 2010, Mr. Wallace vested in fifty percent (50%) of such RSUs.
Pursuant to the terms of the February 17, 2006 RSU grant, 14,219 shares of KLA-Tencor common stock were automatically withheld at vesting to cover required tax withholding. The fair market value of KLA-Tencor common stock used for purposes of calculating the number of shares to be withheld was the closing price of KLA-Tencor common stock as reported on the NASDAQ Stock Market on such vesting date.
