On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, and pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, this option which was previously reported as an option for 1,220 shares of common stock at an exercise price of \$18.10 per share, was adjusted to 2,440 shares of common stock at an exercise price of \$9.05 per share.

(2) On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, the reporting person received 1,000 shares of common stock on March 19, 2010. At the same time, pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, options for 62,744 shares of common stock held by the reporting person on March 19, 2010 became exercisable for 125,488 shares of common stock upon vesting, and awards of restricted stock units for 17,326 shares of common stock held by the reporting person on March 19, 2010 became issuable for 34,652 shares of common stock upon vesting.

(3) On February 16, 2010, NetLogic Microsystems Inc. declared a stock dividend, payable to all holders of record of common stock on March 5, 2010, of one share of common stock for each share of common stock outstanding. As a result, and pursuant to anti-dilution provisions of NetLogic Microsystems' equity incentive plans, this option which was previously reported as an option for 260 shares of common stock at an exercise price of \$13.00 per share, was adjusted to 520 shares of common stock at an exercise price of \$6.50 per share.
