- (2) Certificate of Incorporation. Contemporaneous with such allocation or distribution, Charles E. Dobrusin and Harry B. Rosenberg, solely in their capacities as co-trustees of the Reporting Person, have executed a joinder to, and thereby have become subject to the provisions of, the Amended and Restated Global Hyatt Agreement. Accordingly, immediately following the allocation, the shares will remain shares of Class B Common Stock.
