Each restricted stock unit represents a contingent right to receive one (1) share of the Issuer's Common Stock. Equity granted by Issuer to
- (2) Reporting Person is held by the Reporting Person on behalf of Oak Investment Partners XII, Limited Partnership ("Oak XII, L.P."). Reporting Person is a Managing Member of Oak Associates XII, L.L.C., the General Partner of Oak XII, L.P. The Oak XII, L.P. partnership agreement does not permit receipt of restricted stock units. Accordingly, the Reporting Person was unable to accept the grant as originally reported.
