- (1) The sale was effected pursuant to a Rule 10b5-1 trading plan initially adopted by the reporting person on May 25, 2011. The plan provides for the sale of a maximum of approximately 64,255 shares of common stock (based on estimated tax withholding upon RSU vesting and provided specified minimum trading prices are satisfied, as applicable). After the last transaction reported on this Form 4, a maximum of approximately 32,150 shares remain available for sale under the plan (based on estimated tax withholding upon RSU vesting and provided specified minimum trading prices are satisfied, as applicable). The plan expires on the earlier of May 25, 2013, or the date all shares under the plan are sold.
