- (1) 100% vest on January 3, 2013 if Mr. Dumbrell meets or exceeds the internal organic revenue and contribution margin targets set for his organization.
- (2) 100% vest on January 3, 2013 provided that Mr. Dumbrell's submitted and approved fiscal year 2013 operating plan for his organization meets or exceeds the internal target revenue growth percentage over fiscal year 2012.
- (3) 25% of these options will vest on January 3, 2013. An additional 6.25% of these options will vest at the end of each subsequent three month period such that the options are fully vested on January 3, 2016.
