(1) 811 shares were withheld from the 2,500 restricted shares that vested on May 30, 2014. These 2,500 shares were awarded to Mr. Pahwa on May 30, 2012 as part of an award of 5,000 restricted shares. These vested shares were valued at the NYSE closing market price on May 30, 2014.
