(1) On July 23, 2014, the Compensation Committee of the Board of Directors of the Issuer determined that the performance conditions were met with respect to 5,250 of the 21,000 Performance Share Units granted to Mr. Massaroni on September 9, 2013. The 5,250 Ordinary Shares will vest on September 9, 2014, subject to the continuous service through such date.

(2) Includes 166 Ordinary Shares purchased by the Reporting Person on January 31, 2014 under the Issuer's Employee Stock Purchase Plan. Such acquisition is exempt from reporting pursuant to Rule 16b-3 under the Securities Exchange Act of 1934.
