Unilever NV announces that on 3 April 2007 it purchased 400,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 21.830 and euro 22.014 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 255,355 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 57,463,660 Unilever NV ordinary shares in treasury, and has 1,657,264,040 Unilever NV ordinary shares in issue (excluding treasury shares).
