Unilever NV announces that on 25 September 2007 it purchased 500,000 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between euro 22.040 and euro 22.230 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 35,580 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 95,015,418 Unilever NV ordinary shares in treasury, and has 1,619,712,282 Unilever NV ordinary shares in issue (excluding treasury shares).
