( CEOC ), has amended its previously announced cash tender offers for any and all of its 5.625% Senior Notes due 2015 (the 5.625% Notes ) and any and all of its 10.00% Second-Priority Senior Secured Notes due 2015 (the 10.00% Notes ), subject to financing and other conditions.
