On April 3, 2017, Heidrick & Struggles International, Inc. (HSII) announced that Tracy R. Wolstencroft, the Chief Executive Officer of HSII, is taking a three-month medical leave of absence for treatment of a benign lung condition. In connection with Mr. Wolstencroft s leave of absence, effective April 3, 2017, the HSII Board of Directors appointed Krishnan Rajagopalan, HSII s Executive Vice President and Managing Partner - Executive Search, as acting Chief Executive Officer and interim principal executive officer.

Mr. Rajagopalan joined the firm in 2001 in executive search.
