- (1) 1,964 previously owned shares having a market value of \$13.16 per share were delivered in payment of the option price of \$11.19 per share for 2,310 shares acquired pursuant to the exercise of an option granted under the 2002 Performance Plan.
- (2) 2,310 shares were acquired pursuant to the exercise of an option granted under the 2002 Plan. The option purchase price was paid in accordance with the 2002 Plan in the form of 1,964 shares valued in accordance with the 2002 Plan. In addition, 165 shares were withheld

to pay Federal withholding taxes as permitted by the 2002 Plan and option grant. As a result of the transaction reported herein, the reporting person increased the number of shares beneficially owned by 181 shares.

- (3) Exercise of Non-Qualified Stock Option granted on 10/5/2004 under the 2002 Plan.
- (4) The option vests and becomes exercisable in 25% increments over four years commencing one year after the date of grant.
- (5) Pursuant to the terms of the plan, a reload option was granted for the number of shares tendered in payment of the option exercise price.
