- These restricted stock units vest 100% on February 7, 2009 but are subject to forfeiture in the event financial objectives relating to wireless subscription additions, adjusted OIBDA (operating income plus depreciation, amortization and special items) and post-paid wireless subscriber retention are not achieved during 2006.

Effective at the time of the spin-off by Sprint Nextel of its local communications business, outstanding deferred shares representing Sprint Nextel stock granted under the Nextel Incentive Equity Plan were adjusted by multiplying the number of shares by 1.0955. This number was obtained by dividing the "regular way" closing price of Sprint Nextel common stock on the NYSE on May 17, 2006 by the "ex-dividend" closing price of Sprint Nextel common stock on the NYSE on May 17, 2006.
