- (1) Represents Deferred Stock Units issued to Ms. Miskovic by NRG Energy, Inc. under NRG Energy, Inc.'s Long Term Incentive Plan.
 - (2) Ms. Miskovic elected to receive Deferred Stock Units in lieu of the cash portion of her compensation. 1,801 Deferred Stock Units of the 3,602 units represent the cash portion of Ms. Miskovic's compensation.
- Each Deferred Stock Unit is equivalent in value to one share of NRG Energy, Inc.'s Common Stock, par value \$0.01. Ms. Miskovic will receive from NRG Energy, Inc. one such share of Common Stock for each Deferred Stock Unit she owns upon termination of her service on NRG Energy, Inc.'s Board of Directors.
- (3) On May 2, 2007, NRG Energy, Inc. announced a 2-for-1 stock split, in the form of a stock dividend paid on May 31, 2007 to all holders of record of Common Stock on May 22, 2007, which resulted in Ms. Miskovic's ownership of 6,134 additional shares of Common Stock. The Company's Common Stock began trading on a split-adjusted basis on June 1, 2007.
