Shares of the Issuer's Class B common stock were issued to the Reporting Person upon certification by the Compensation Committee of the Issuer's Board of Directors on January 20, 2010 of the vesting of previously granted Performance Share Units ("PSUs") based on the attainment of specified performance criteria for the period January 1, 2007 through December 31, 2009. The PSUs were granted to the Reporting Person for no consideration on May 29, 2007. On January 20, 2010, the closing price of the Issuer's Class B common stock on the New York Stock Exchange was \$30.71 per share.
