- The reported transaction involves an award of restricted stock units under the M&T Bank Corporation 2009 Equity Incentive Compensation Plan. Each restricted stock unit represents a contingent right to receive one share of M&T Bank Corporation common stock upon vesting.
- (1) The restricted stock unit award includes a total of 5,834 shares. 583 shares of the restricted stock unit award will vest on January 31, 2014; an additional 1,167 shares will vest on January 30, 2015; an additional 1,750 shares will vest on January 29, 2016; and the remaining 2,334 shares will vest on January 31, 2017.
  - (2) The restricted stock units were granted under an equity incentive compensation plan maintained by M&T Bank Corporation, and therefore the reporting person paid no price for the restricted stock units.
  - (3) The restricted stock unit award includes a total of 2,863 shares. 858 shares of the restricted stock unit award will vest on January 30, 2015; an additional 859 shares will vest on January 29, 2016; and the remaining 1,146 shares will vest on January 31, 2017. This restricted stock unit award is intended to meet the requirements of the TARP Interim Final Rule's definition of "long-term restricted stock" as the award relates to the reporting person's performance during the period of time in 2012 that M&T continued to have an outstanding TARP obligation.
