Issued pursuant to the Popular, Inc. 2004 Omnibus Incentive Plan consistent with the requirements of the Interim Final Rule on TARP Standards for Compensation and Corporate Governance issued by the U.S. Department of the Treasury in June 2009. The shares will vest (1) on the second anniversary of the grant date. In order to be transferable, the Corporation must have achieved profitability for at least one fiscal year.
