Restricted Share Units (the "RSUs") and (ii) an additional 76,240 shares were issued upon the certification by the Compensation Committee of the Issuer's Board of Directors on November 13, 2013 of the vesting of additional RSUs based on the attainment of specified performance criteria for the Issuer's fiscal year 2013. The RSUs were granted to the Reporting Person for no consideration on May 27, 2010. On November 13, 2013, the closing price of the Issuer's Class B Common Stock on The NASDAQ Global Select Market was \$83.13 per share.
