Subject to the achievement of the Performance Milestones, the RSUs vest in three equal annual installments beginning on January 30, 2018. The Compensation Committee of the Board of Directors certified the applicable Performance Milestones were achieved on January 30, 2018.
  - (2) Represents shares of HA common stock issued upon the vesting of performance based RSUs granted on March 30, 2017. The Compensation Committee of the Board of Directors certified the applicable Performance Milestones were achieved on January 30, 2018.
  - (3) Represents shares of HA common stock issued upon the vesting of performance based RSUs granted on February 3, 2015. The Compensation Committee of the Board of Directors certified the applicable Performance Milestones were achieved on January 30, 2018.
