The total amount of securities reported as indirectly owned by the reporting person includes 2,690 shares acquired from June 1, 2008 through July 31, 2008, pursuant to the Company's 401(k) Plan. The information is based on a report dated July 31, 2008, provided by the Company's Plan Trustee.

RSUs deferred as phantom shares of Common Stock are payable only in shares of Common Stock at the end of the deferral period. The reporting person has elected to settle the vested RSUs for cash.
