- (1) This Rule 16b3 exempt stock option, granted under the Issuer's 2004 Incentive Compensation Plan, will vest ratably on each of the first four anniversaries of the date of grant, such that the option will be fully vested on October 15, 2011 (provided applicable provisions of such option are complied with).
- (2) Exempt grant of Restricted Stock Units under the Issuer's 2004 Incentive Compensation Plan. Each restricted unit represents a contingent right to receive one share of the issuer's common stock. The Restricted Stock Units will vest as to 100% of the shares on October 15, 2010, the third anniversary of the date of issuance, provided that certain conditions are met.
