**BHP BILLITON PLC - TRANSACTION IN SHARES**

BHP Billiton Plc announces that, further to the resolution approved at the AGM held on 26 October 2006 relating to the reduction of share capital in BHP Billiton Plc by the cancellation of all the shares held by BHP Billiton Limited on 15 May 2007, 19,650,000 ordinary shares of BHP Billiton Plc were cancelled on 5 July 2007 and a sum of US\$9,825,000 being equal to the reduction in share capital, was transferred to a special reserve. The total number shares cancelled under the authorities granted at the AGM currently amounts to 121,335,000 ordinary shares of US\$0.50 each.

In addition, BHP Billiton Limited announces that on 5 July 2007 it purchased 500,000 ordinary shares of BHP Billiton Plc at an average price of 1461.8801 pence per ordinary share.

Following the above transaction, BHP Billiton Plc holds 24,910,000 of its ordinary shares as treasury shares and BHP Billiton Limited holds 20,786,714 of the ordinary shares in BHP Billiton Plc, for a total of 45,696,714 shares. The
