The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Issuer: JPMorgan Chase Financial Company LLC.

Guarantor: JPMorgan Chase & Co.

Minimum Denomination: \$1,000.00

Indices: S&P 500 Index and Russell 2000 Index

Pricing Date: December 27, 2018

Observation Date: December 28, 2021

Maturity Date: December 31, 2021

Upside Leverage Factor: At least 1.20*

Contingent Buffer Amount: 25.00%

Payment At Maturity: If the Final Value of the Lesser Performing Index is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return} \times \text{Upside Leverage Factor})$

If the Final Value of the Lesser Performing Index is equal to its Initial Value or is less than its Initial Value by up to the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Absolute Index Return of the Lesser Performing Index})$

If the Final Value of the Lesser Performing Index is less than its Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$

If the Final Value of the Lesser Performing Index is less than its Initial Value by more than the Contingent Buffer Amount, you will lose more than 25.00% of your principal amount at maturity and could lose all of your principal amount at maturity.
