On October 22, 2003, Westcorp held a conference call with its subsidiary company WFS Financial Inc. In this conference call, earnings guidance was provided, as follows:

Consistent with our previous guidance, we expect earnings to be \$2.75 per share for all of 2003 at Westcorp and \$3.40 per share for 2004

We expect earnings at WFS Financial to be around \$3.90 per share for all of 2003 down from \$4.00 per share and commensurate with the increase in the amount of loans sold to Westcorp during the quarter.
