ASUR Announces Total Passenger Traffic for

June 2016 Up 8.3% Year over Year

**Mexico City, July 5, 2016 - Grupo Aeroportuario del Sureste, S.A.B. de C.V. (NYSE: ASR; BMV: ASUR)** (ASUR), the first privatized airport group in Mexico and operator of Cancun Airport and eight other airports in southeast Mexico, as well as a 50% JV partner in Aerostar Airport Holdings, LLC, operator of the Luis Muñoz Marín International Airport in San Juan, today announced that total passenger traffic for June 2016 increased by 8.3% when compared to June 2015.

This announcement reflects comparisons between June 1 through June 30, 2016 and 2015. Transit and general aviation passengers are excluded.
