On February 17, 2005, Inland Real Estate Corporation (the "Company") issued a press release announcing that the Company had acquired Greentree Centre, a 159,268 square-foot multi-tenant retail center located in Caledonia,

Wisconsin. The Company agreed to pay the sellers approximately \$11.9 million at the closing, plus future contingent payments in aggregate maximum amount of approximately \$1.7 million as currently vacant space is leased. Also on February 17, 2005, the Company issued a press release announcing that the Company had paid a cash dividend of \$0.0783 per share on the outstanding shares of its common stock to common stockholders of record at the close of business on January 31, 2005. On February 21, 2005, the Company issued a press release announcing that the Company has declared a cash dividend of \$0.0783 per share on the outstanding shares of its common stock, payable on March 17, 2005 to common stockholders of record at the close of business on March 4, 2005. A copy of the press release is attached to this Current Report on Form 8-K as Exhibit 99.3 and is incorporated in its entirety in this Item 8.01 disclosure by reference.
