EXHIBIT A

ITEM 6. OWNERSHIP.

TIAA-CREF Investment Management, LLC ("Investment Management") is the investment adviser to the College Retirement Equities Fund ("CREF"), a registered investment company, and may be deemed to be a beneficial owner of 11,506,631 shares of Issuer's common stock owned by CREF. Teachers Advisors, Inc. ("Advisors") is the investment adviser to three registered investment companies, TIAA-CREF Funds ("Funds"), TIAA-CREF Life Funds ("Life Funds"), and TIAA Separate Account VA-1 ("VA-1"). Advisors is also the investment adviser to the TIAA-CREF Asset Management Commingled Funds Trust I ("TCAM Funds") and four Active Extension Funds (collectively, the "Unregistered Funds"). Consequently, Advisors may be deemed to be a beneficial owner of 1,499,937 shares of Issuer's common stock owned by the Funds, Life Funds, VA-1, TCAM Funds and Unregistered Funds. Investment Management and Advisors are reporting their combined holdings for the purpose of administrative convenience. These shares were acquired in the ordinary course of business, and not with the purpose or effect of changing or influencing control of the Issuer. Each of Investment Management and Advisors expressly disclaims beneficial ownership of the other's securities holdings and each disclaims that it is a member of a "group" with the other.
