XL Group plc's Annual General Meeting will be held on May 6, 2011 at the Merrion Hotel, Upper Merrion Street, Dublin 2, Ireland, at 8:30 a.m. local time.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board recommends a vote FOR all nominees, FOR Proposals 2, 3 and 5 and FOR every 1 YR on Proposal 4:

1. To elect four Class I Directors to hold office until 2014.
Nominees: Herbert N. Haag, Michael S. McGavick, Ellen E. Thrower, John M. Vereker
2. To ratify the appointment of PricewaterhouseCoopers LLP, New York, New York to act as the independent registered public accounting firm of the Company for the year ending December 31, 2011.
3. To provide a non-binding, advisory vote approving the Company's executive compensation.
4. To provide a non-binding, advisory vote on the frequency of future executive compensation votes.
5. To approve the increase in the number of shares available for issuance under the Company's 1991 Performance Incentive Program.

Only the holders of record of XL Group plc Ordinary Shares on March 3, 2011 are entitled to notice of and to vote at the meeting. If you were a shareholder as of the record date, you may attend the Annual General Meeting and vote in person.
