## Schedule 13D

Item 1. Security and Issuer.

This Amendment No. 1 ("Amendment No. 1") to Schedule 13D amends and supplements the statement on 13D originally filed on January 26, 2018 relating to the common shares, \$0.001 par value (the "Common Stock"), of Genoclea Biosciences, Inc. (the "Issuer") having its principal executive office at Cambridge Discovery Park, 100 Acorn Park Drive, 5th Floor, Cambridge, Massachusetts 02140.

Certain terms used but not defined in this Amendment No. 1 have the meanings assigned thereto in the Schedule 13D. Except as specifically provided herein, this Amendment No. 1 does not modify any of the information previously reported on the Schedule 13D.

Item 2. Identity and Background.

Sonsini ("Sonsini") and Paul Walker ("Walker") (together, the "Managers") and Chetan Puttagunta ("Puttagunta"), Jon M. Sakoda ("Sakoda") and Ravi Viswanathan ("Viswanathan"). The Managers are the managers of NEA 16 LLC.

The persons named in this Item 2 are referred to individually herein as a "Reporting Person" and collectively as the "Reporting Persons."

The principal business of NEA 16 is to invest in and assist growth-oriented businesses located principally in the United States. The principal business of NEA Partners 16 is to act as the sole general partner of NEA 16. The principal business of NEA 16 LLC is to act as the sole general partner of NEA Partners 16. The principal business of each of the Managers is to manage the Control Entities, NEA 16 and a number of affiliated partnerships with similar businesses.

During the five years prior to the date hereof, none of the Reporting Persons has been convicted in a criminal proceeding or has been a party to a civil proceeding ending in a judgment, decree or final order enjoining future violations of, or prohibiting or mandating activities subject to, federal or state securities laws or finding any violation

with respect to such laws.

NEA 16 LLC is a limited liability company organized under the laws of the State of Delaware. NEA 16 and NEA Partners 16 are limited partnerships organized under the laws of the State of Delaware. Each of the Managers is a United States citizen.

Item 3. Source and Amount of Funds or Other Consideration.

On February 14, 2019, NEA purchased in a private placement transaction (the "Transaction") an aggregate of 9,948,269 shares of the Issuer's Common Stock at a purchase price of \$0.4713 per share (the "NEA 16 Shares") and a Class B warrant to purchase, subject to certain limitations, up to an aggregate of 2,487,067 shares of the Issuer's Common Stock (the "NEA 16 Warrant Shares"), exercisable immediately at a purchase price of \$311,380.82 for such warrant (the "NEA 16 Warrant"). Prior to the Transaction, NEA 16 held 25,000,000 shares of the Issuer's Common Stock (the "Prior NEA 16 Shares") and warrants to purchase 12,500,000 shares of the Issuer's Common Stock (the "Prior NEA 16 Warrant Shares" and, together with the NEA 16 Shares, the NEA 16 Warrant, the NEA 16 Warrant Shares and the Prior NEA 16 Shares, the "Securities"). NEA 16 now holds a total of 34,948,269 shares of the Issuer's Common Stock and warrants to purchase 14,987,067 shares of the Issuer's Common Stock.

The working capital of NEA 16 was the source of the funds for the purchase of the Securities. No part of the purchase price of the Securities was represented by funds or other consideration borrowed or otherwise obtained for the purpose of acquiring, holding, trading or voting the Securities.

NEA 16 acquired the Securities for investment purposes. - (d) Any change in the present board of directors or management of the Issuer, including any plans or proposals to change the number or term of directors or to fill any existing vacancies on the board;
- (e) Any material change in the present capitalization or dividend policy of the Issuer;
- (f) Any other material change in the Issuer's business or corporate structure;
- (g) Changes in the Issuer's charter, bylaws or instruments corresponding thereto or other actions which may impede the acquisition of control of the Issuer by any person;
