On August 18, 2015, Houlihan Lokey, Inc., a Delaware corporation (the <u>Issuer</u>), completed its initial public offering (<u>IPO</u>), in which selling stockholders and certain employees and members of the Issuer s management, sold 12,075,000 shares of Class A common stock. Following the closing of the IPO and the sale by the selling stockholders, certain of the selling stockholders (the <u>HL Holders</u>), including Mr. Werbalowsky, agreed to hold their shares of Class B common stock (the <u>Trust Shares</u>) indirectly through a new voting trust (the <u>HL Voting Trust</u>) formed pursuant to a voting trust agreement (the <u>Voting Trust Agreement</u>) under which all decisions with respect to the voting (but not the disposition) of the Trust Shares will be made by the trustees of the HL Voting Trust (the <u>Trustees</u>), in their sole and absolute discretion, without fiduciary duties of any kind to the HL Holders. Pursuant to the Voting Trust Agreement the Trustees, acting by majority vote, have voting control over the Trust Shares, but no dispositive power over any of the Trust Shares. Each HL Holder retains sole dispositive power over the shares deposited in the HL Voting Trust.
