Item 8.01. Other Events.

On October 26, 2015, Allied World Assurance Company Holdings, AG (the Company) issued a press release announcing that Allied World Assurance Company Holdings, Ltd, a Bermuda company and a wholly-owned subsidiary of the Company (Allied World Bermuda), priced a registered offering of \$500 million aggregate principal amount of 4.35% Senior Notes due 2025, fully and unconditionally guaranteed by the Company. The net proceeds from the offering will be used for the repayment, upon maturity, of Allied World Bermuda s outstanding \$500 million aggregate principal amount of 7.50% Senior Notes due August 1, 2016, as well as for general corporate purposes, which may include the repurchase of the Company s outstanding common shares, dividends to its shareholders or potential acquisitions. The press release announcing the pricing of the offering is attached as Exhibit 99.1 and incorporated herein by reference.
